

PRIVACY STATEMENT HOUSEHUNTING FRANCHISE B.V.

We process your personal data within the scope of our services. In this privacy statement we explain how Househunting Franchise B.V. uses your (personal) data.

Processing of personal data

Personal data is data that can be used to directly or indirectly identify a natural person, such as, for example, a name, location data (IP address), email address, and telephone number. Househunting Franchise B.V. processes only that personal data that is necessary for entering into and performing agreements regarding the services provided by Househunting Franchise B.V., including carrying out work aimed at increasing its customer base. The basis for this processing is the legitimate interest of Househunting Franchise B.V., or the performance of an agreement. Personal data is also processed in order to comply with mandatory legal requirements. Househunting Franchise B.V. obtains personal data from you, for example the data you provide to us via the website, email address, and telephone number. In addition, we may obtain your personal data through third parties within the framework of our service provision. The personal data we process includes, but is not limited to, first and last name, address details, gender, telephone number, email address, BSN [citizen service number], and other (personal) data provided to Househunting Franchise B.V. Your personal data will not be kept for longer than necessary. After termination of the agreement and/or the relationship, the personal data will be stored for another two years, unless a longer retention period is necessary to comply with a legal (tax) obligation.

Disclosure to third parties

Within the context of the services provided, Househunting Franchise B.V. may disclose personal data to third parties when necessary for the services of Househunting Franchise B.V., including ICT suppliers, franchisees, government agencies or its accountant. Finally, personal data may be disclosed to third parties if Househunting Franchise B.V. is required to comply with a legal obligation. Househunting Franchise B.V. will not sell your data to third parties.

Househunting Franchise B.V. keeps its customers informed of the latest developments. Each newsletter contains a link for unsubscribing.

Cookies (Google Analytics)

Househunting Franchise B.V. uses Google Analytics to track how you use our website. This enables us, for example, to improve our website and services. Google Analytics uses cookies to perform the analysis and to provide technical support.

We have concluded a data processing agreement with Google and have chosen not to share data with Google for its own purposes. The data processing agreement contains strict agreements about what Google may keep track of. Data that is recorded includes your IP address (of which the last 3 digits are masked), the number of pages visited, the time and duration of the visit, your location, the origin of the visit, type of hardware and software used, visitor interaction, and your search history. The information obtained will be transferred to Google and stored by Google on servers in the United States, a country that does not have privacy protection similar to that of the European Union.
